Our Mission

Mercy Center creates opportunities for women, men and families in the South Bronx to grow and thrive through education, family, civic, social and economic programs. We build community with a spirit of hospitality, respect and equity in the tradition of the Sisters of Mercy.

Mercy Center takes a holistic approach in helping to transform the quality of life for over 3,000 participants each year in the South Bronx, the poorest urban congressional district in the United States, through free adult education/workforce development, family strengthening, youth enrichment, and immigrant services.

Our History

Founded in 1990, Mercy Center has grown from a volunteer counseling service operating out of a single classroom located in a Mott Haven school into a respected, community-based resource.

Our families come from 42 countries and 66% have an annual household income of \$21,000 or less. Our participants receive the following services at two locations in the South Bronx:

Our Classes, Programs, Services in FY22

Adult Education and Workforce Development

- English for speakers of Other Languages (ESOL), High School Equivalency (HSE) and Adult Basic Education (ABE) – over 1,500 enrolled
- 97% promoted to the next level of study
- Work Readiness Program – 74 participants secured new or improved employment

Immigrant Services – New Americans Opportunity Center

- 123 naturalization, DACA, and Green Card renewal applications
- 95 enrolled in citizenship classes

Family and Youth Programs

- Family Strengthening Collaborative - 180 families reached
- After School, Saturday Reading Enrichment, and other Youth Programs – 114 children enrolled
- Parenting and Anger Management classes and Moms' and Dads' Support Group – 240 participants

Social Services, Community Education, and Personal Development

- Social Services – 412 case management sessions
- Community Education webinars – 469 participants

U.S. Open Tennis Raffle




1,380 participants enrolled in **ESOL classes (English for Speakers of Other Languages)**.

WORKFORCE DEVELOPMENT



Additionally, **62** participants completed **Skills for Employment Success Workshops**, and **51** participants attended **Networking Meetings**.

IMMIGRANT SERVICES

123 applications were submitted for **naturalization**, **DACA renewals**, and **Green Card renewals**.

80 participants received an **immigration legal consult** with an ONA (Office for New Americans) attorney.

95 participants enrolled in **Citizenship classes**.



FAMILIA ADELANTE

103 families in ongoing case management, exceeding the goal of 90

6 families in maintenance

180 families reached by program activities

88% of families achieved Adult Well-Being behavioral goals



FAMILY SKILLS

240 participants enrolled in *Parenting and Anger Management classes and the Mothers' Support Group*, many of them enrolling in multiple programs.



We achieved **106%** of our attendance goals and

YOUTH PROGRAMS


Youth *activity hours* totaled **13,815**

540 families at *Thanksgiving*.




560 children received *Christmas* gifts.

Our Finances

- We had **204** new donors and **199** reactivated donors.
- Our first in-person Gala since the pandemic exceeded our goals, grossing **\$313,220**.
- Overall, Special Events exceeded our goal by over **\$21,000**.
- Grant awards exceeded our goal by **3%**, with **20%** of total grant income coming from new and increased grant awards.
- Our **\$411,680** PPP loan was completely forgiven.




