Our Mission

Mercy Center creates opportunities for women, men and families in the South Bronx to grow and thrive through education, family, civic, social and economic programs. We build community with a spirit of hospitality, respect and equity in the tradition of the Sisters of Mercy.

Mercy Center takes a holistic approach in helping to transform the quality of life for over 3,700 participants each year in the South Bronx, the poorest urban congressional district in the United States, through free adult education/workforce development, family enrichment, and immigration services.

Our History

Founded in 1990, Mercy Center has grown from a volunteer counseling service operating out of a single classroom located in a Mott Haven school into a respected, community-based resource.

Our families come from 51 countries and 65% have an annual household income of \$21,000 or less. Our participants receive the following services at two locations in the South Bronx:

Our Classes, Programs, Services in FY23

Adult Education and Workforce Development

- English for Speakers of Other Languages (ESOL) – over 1,800 enrolled; 93% increased their test score by at least 30 points and were promoted to the next level
- Work Readiness Program – 87 participants secured new or improved employment; 90 participants attended employment skills workshops or networking meetings

Immigrant Services – New Americans Opportunity Center

- Naturalization applications, fee waiver applications, green card and DACA renewals – 481 applications submitted

Asylum Seeker Case Management

- Case Management Services – 468 Asylum Seekers received services
- ESOL - 116 Asylum Seekers enrolled in ESOL classes offered by Mercy Center at a HERRC (Humanitarian Emergency Response and Relief Center) shelter

Family and Youth Programs

- After School and other Youth Programs – 21,543 youth activity hours; 99% of after school children were promoted to the next grade
- Parenting and Anger Management classes and Moms Support Group – 217 participants
- Christmas – 609 children received gifts for Christmas

Social Services, Community Education, and Personal Development

- Social Services – 237 participants for a total of 442 case management sessions
- Community Education webinars – 878 participants

U.S. Open Raffle

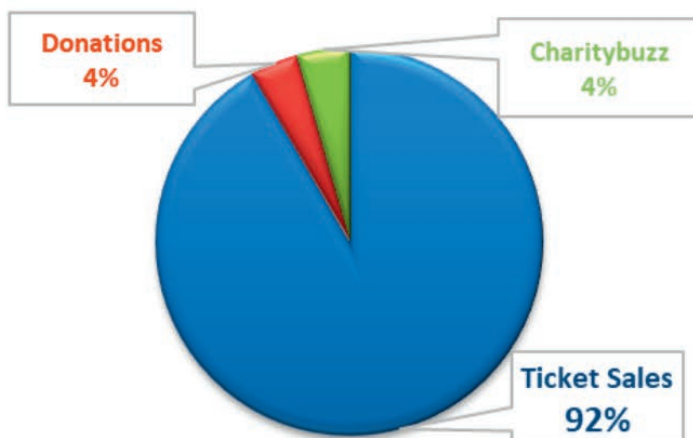

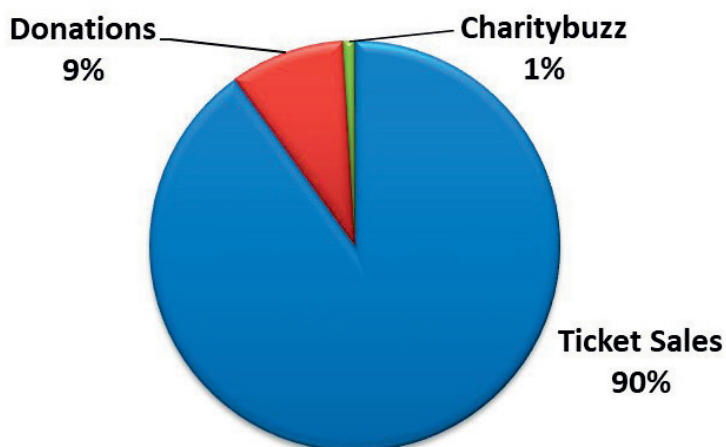

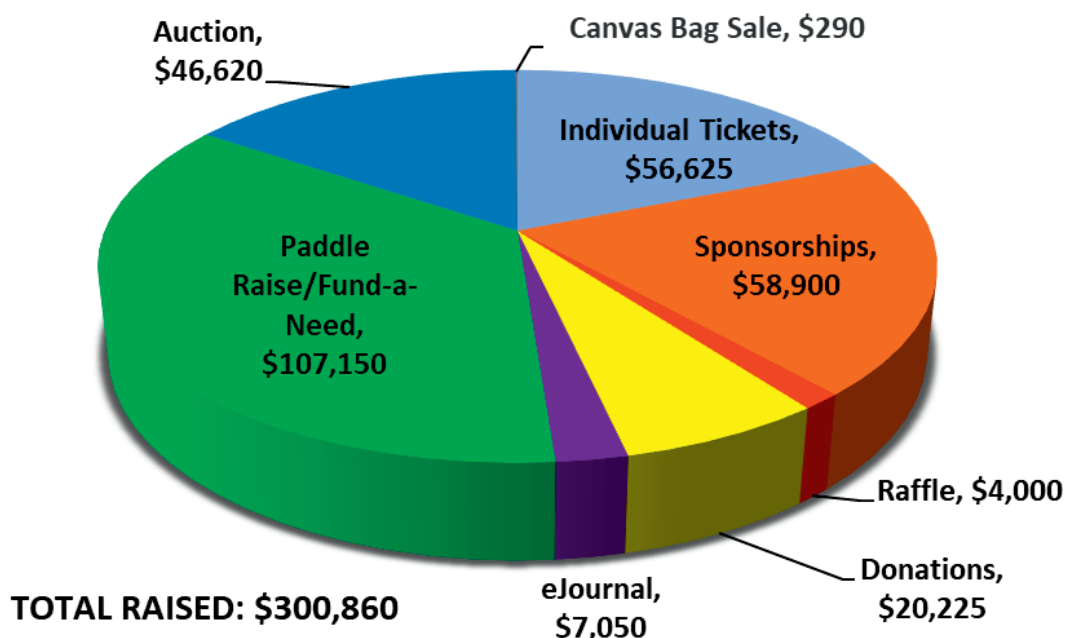


We also acknowledged the work of Alba Torres, who recently retired after serving 32 years at Mercy Center. She received a citation from the Mayor's Office as a memento of her service.

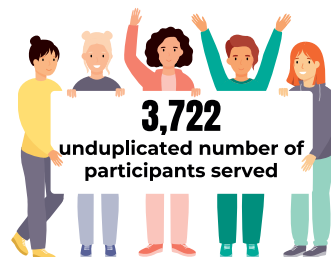

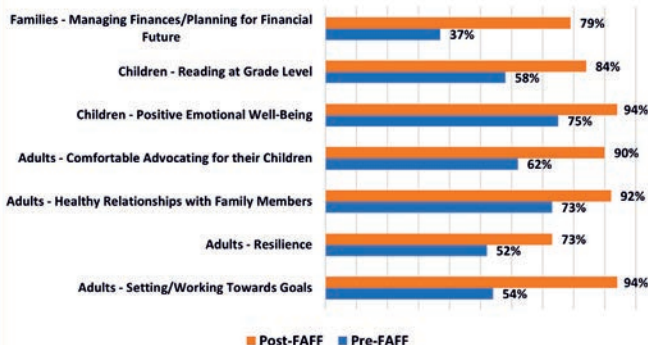

Familia Adelante Outside Evaluation Sample Results



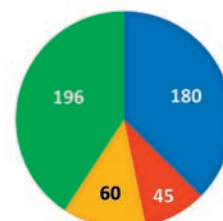

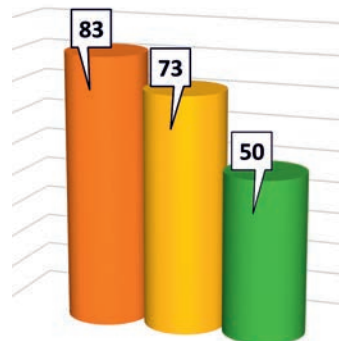
