








Sister Mary Ann Dirr Legacy Circle

John Bucki SJ Youth Fund

Father John Bucki, SJ, devoted his life to justice, faith, and the young people of the South Bronx. A champion of Mercy Center's mission, he inspired service through the Week of Winter Service and strengthened our youth programs. Our Mission

Mercy Center creates opportunities for women, men and families in the South Bronx to grow and thrive through education, family, civic and economic programs. We build community with a spirit of hospitality, respect and equity in the tradition of the Sisters of Mercy.

Our History

Founded in 1990, Mercy Center has grown from a volunteer counseling service operating out of a single classroom located in a Mott Haven school into a respected, community-based resource.

Mercy Center takes a holistic approach in helping to transform the quality of life for over 4,200 participants each year in the South Bronx, the poorest urban congressional district in the United States, through free adult education and workforce development classes, immigration and asylum seeker legal services, social services and family and youth programs. Our participants come from 55 countries and 62% have an annual household income of \$21,000 or less.

Our Classes, Programs & Services in FY25

Adult Education & Workforce Development

- **English for Speakers of Other Languages (ESOL):** 1,580 enrolled; 100% increased their English proficiency score by at least 30 points, and 99% advanced to the next level.
- **Work Readiness Program:** 392 participants received work readiness assistance. Of these, 169 reported new or improved employment, 195 completed a series of skills development workshops, and 103 took part in networking meetings.

Immigration & Asylum Seeker Services

- **Total applications submitted:** 1,862 — including 116 naturalization, 32 DACA, 52 green card renewal, 200 fee waiver, 359 asylum, 959 employment authorization, and 127 change of address or venue.
- **Legal Consultations:** 2,126 legal consultations were conducted.

Family & Youth Programs

- **After School, Summer Camp and Enrichment Youth Programs:** Nearly 18,000 youth activity hours provided.
- **Parenting and Anger Management classes:** 164 participants enrolled in classes in English and Spanish.
- **Familia Adelante collaborative:** 105 families engaged in ongoing comprehensive family-strengthening and financial coaching; 38 families graduated from the program, and 24 new families enrolled.


Social Services, Community Education & Personal Development

- **Social Services:** 608 participants engaged in a total of 1,322 case management sessions.
- **Personal Development and Community Education/Events:** Nearly 1,600 participants engaged in community education, personal development and/or community-building events.






